

**ORDINANCE NO. 2022-\_\_\_\_\_**

**AN ORDINANCE AMENDING THE RATES AND CHARGES  
FOR THE WATERWORKS UTILITY**

WHEREAS, the Dayton Water Works (“Waterworks”), in Dayton, Indiana (“Town”) operates a Waterworks utility for the benefit of the ratepayers within the Town and in the surrounding area;

WHEREAS, various ordinances have been adopted from time to time regarding policies and procedures for the water works and the establishment of water rates, fees and charges;

WHEREAS, the existing rates, fees and charges are set forth in the earlier ordinance, Ordinance No. 12-2012;

WHEREAS, the State of Indiana has repealed its Utility Receipts Tax and utilities are required to reduce rates to reflect the elimination of this 1.40% tax; and

WHEREAS, it has been determined by the Town Council that the Utility Receipts Tax should be repealed;

NOW, THEREFORE BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF DAYTON, as follows:

1. The Utility Receipts Tax is hereby repealed.
2. WATER RATES – for use of and service rendered by the waterworks, each user shall be charged in an amount based upon a fee schedule, as shown in Appendix A.

All other provisions of the Town’s current water rates and charges not amended by this ordinance shall remain in full force and effect.

The provisions herein, when approved and adopted, shall be effective beginning with the July 2022 consumption period and billed for the August 2022 billing period.
