Utility Superintendent Report:

Meter Pit Antenna- Going to order 6 more @ \$30 each to have extras on hand.

Resident concerns- Addressed concerns of stained water. Ended up being homeowner's water softener is not working correctly.

College Street Lift Station- Pump was running twice the hours than the other one. There was a piece of plastic that was stuck. Now is fixed.

Drainage Easements- 3 homeowners are in support of the cleaning of the ditches. All in agreement to sign the drainage easement. Need to get ahold of final 3 homeowners. Then will work with Reid regarding the drainage easement.

CCMG Construction Cost- Must submit CCMG by January 29. Total cost is \$294,607 for construction and the town's share will be \$73,652.
