American Rescue Plan Discussion:

Jen stated that she had the idea of giving out grants to small businesses in town. She stated that some small businesses have already received grant money. She stated that Red Bird already received \$350,000, so she believes that businesses that have already received this money or businesses owned by council members would be excluded from receiving the money.

Carla asked if there would be certain guidelines that would be established on how the money would be used by the business that receives it.

Ron stated that he doesn't like how Lafayette hands out huge amounts to a few law businesses and then only give a couple thousand of dollars to small businesses. He stated that the businesses that get the large amounts of money, close down more and aren't open as many hours.

Ashley stated that the reduced hours tend to have to do with staffing issues. Ron stated that the companies that receive the \$300,000 or \$1 million dollars then you shouldn't have too many staffing issues because the money is to help pay the people, unless you are cheap and don't pay them much.

Annexation of Dayton Property:

Jen wants to give the Town Attorney the authorization to look into the annexation of the strip of land that goes from the town limits up to 200.

Stan stated that he thinks that any land that the town owns should be in the town limits. Ron stated that they want to be able to control that land to do what they want with it.

Ashley stated that he thinks the town should work with the county and not butting heads with them. Carla wants to gather the information and then make a decision.

Four council members agreed to have the town attorney look into annexation of the land owned by the town from the town limits up to 200.
