Rocky Richards called the meeting to order.

Present at the meeting were Rocky, Leah, Marc, and Carla. Also present were clerk-treasurer Bridget, and Attorney Alicia Albertson.

The purpose of this meeting is to fill a vacancy of a Town Councilman. The four town members who have shown interest in this position are Vicki Beavers, Rob Hainje, Mike Harris, and Steve Schuhle. Each candidate was given time to introduce themselves.

Rocky made a motion to elect Mike Harris and Leah seconded the motion. Roll call vote, Leah-yes, Rocky-yes, Marc-no, Carla-no, Bridget abstains. Vote 2-2. Motion does not carry.

Leah nominates Steve Schuhle and Rocky seconds the motion. Roll call vote, Leah-yes, Rocky-yes, Marc-no, Carla-no, Bridget-yes. Passes 3-2. Marc retracts his no vote for Steve Schuhle to be on the board and changes it to a yes. Passes 4-1.

Rocky made a motion to elect Steve as the new President of the town council. Marc asks to be considered as President. Rocky seconded his motion. Leah makes a motion to make Marc the President and Rocky seconds the motion. Roll call, Leah-yes, Rocky-yes, Marc abstains, Carla-yes. Passes 3-0. Marc selects Carla as the Area Plan representative and Steve as the Police representative.

Leah would like to have an Easter Egg Hunt for the town children. She has asked for a \$500 spending limit. It will be held on April 6, 2024, on the field across from the BP.


Marc made a motion to allow an amount not to exceed \$500, any additional amount spent will come from donations from outside vendors. Rocky seconded it. Roll call Leah-yes, Rocky-yes, Marc-yes, Carla-yes. Passes 4-0.

Public Comment

Christine Edwards asked about advertising for the Easter Egg Hunt. Leah said the town website, Facebook page, posters, and signs in town and sending a letter home with children at the elementary school.

Marc adjourned the meeting.
