APC Ordinance – Storage Warehouses in urbanized sewaged areas. Staff of APC opposes the APC Ordinance Committee recommendation and wants the town to amend APC recommendation to deny the April amendment and support the January 2022 amendment. Jen made a motion to amend UZO Amendment 103-A Self Storage Warehouses in Urbanized Areas to recommend approval of the original language from January 2022. Carla seconded. Roll call vote.


Billboard contract – contract was originally for five years which would take it to 2016 and they then could extend it for ten years so it can't be revised until 2026.

Ron expressed dismay about how the former clerk had trashed the council in emails to vendors. He also asked what would be done about supplies that had ordered without approval and had been sent to her house. Jen indicated those things would be in the State Board of Accounts audit.

Wesleyan Drive


The council needed to decide if a hammerhead or cul-de-sac would be best to properly terminate Wesleyan Drive. Jen stated she believed a cul-de-sac would be best. Ashley Stevenson has said he will not give one inch to the town for this so the end of the cul-de-sac would be the end of the road. Ron said Stevenson's had removed the end of the road and put the end of their drive over it but that would be taken out and used for the end of the cul-de-sac. Ron Koehler and Cindy Marsh and the church would give land voluntarily. Stan made a motion to put a cul-de-sac at the end of Shady Lane for proper termination. Ron seconded. Roll call vote.
