Adjustment Report:

Utility Superintendent Report:

Lead/Copper Test Results- All came back with good results.

SR 38 water line relocate- INDOT approved loan bid of \$74,000 for KA Contracting.

Water Meter software/annual cost update- Utility Supply stopped by, there is going to be an update to the software. Mark will no longer use the laptop. He will use the Town's IPAD to read meters. The cost will be \$3400 a year rather than the current \$2400 a year. September 3rd, the system will be updated.

Deerfield Lift Station Pump #2- Got the pump back from vendor, it is repaired.

Crosswalk Painting- Straight Lines went through and painted the crosswalks.

ADA Ramps/INDOT- Spoke with INDOT about painting the crosswalks where they are putting in the ADA ramps and INDOT stated that they were.

CCMG Contracts- The council discussed the CCMG contract. Ron Koehler made a motion to sign the state highway contract with Midwest Paving...Stan Kyger seconded the motion...carried roll call 5-0.

Landowner Easements- Been contacted by 2 of 6 homeowners. One homeowner asked if there would be compensation for the easement.

Speed Sign on Dayton Road- The council discussed placing a speed sign out at the new town limits. Stan Kyger made a motion to make the speed limit to the new town limits from Walnut St 25 MPH...Carla Snodgrass seconded the motion...carried roll call vote 5-0.

Public Comment:


