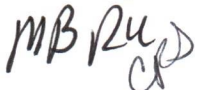
- Donation of land for Wesleyan Drive is completed and deeds are recorded.
- Change voting cycle to presidential year can't be done but can do midterm (even numbered) election year. Take under consideration.
- Move regular meeting to 3rd Tuesday of the month in 2023.
- Changes required meeting notice to match the state statute – 48 hours notice required.
- Abolishing wards.

Alicia will make an Ordinance to create a TIF Fund.

The council needs to decide if the TIF should pay the town back for the expenses incurred in the creation of the TIF. Marc said he felt it was his responsibility as president of the Dayton Redevelopment Commission to ask forgiveness of that debt and explained why. Alicia will look into whether repayment is allowed.

Cindy Marsh 749 Shady Lane offered her opinion on whether the town should be reimbursed. Dayton taxpayers paid all the fees for professional services creating the TIF and now are being impacted with higher property taxes because the town's assessed value is less. With a smaller assessed value the percentage needed to make our levy has to be higher.

Discussion of possible TIF projects were discussed.

Fire Contract

The 2023 contract with the Sheffield Township Volunteer Fire Department is for \$29,070 in two equal installments.

Marshal Taylor

- Railroad foot bridge. He's concerned about liability. Discussion followed.
- Yearly maintenance fee on old software continues to be billed but we're not paying.
- Surplus property – Old Christmas decorations have no value and need to be disposed of.

- Budget considerations: would like to raise part-time rate from \$27 to \$30; increase insurance stipend to \$500; allow full-time deputy to earn overtime on weekends; Discussion followed.
- Would like the council to consider ordering a 2023 Squad car. 2015 has 70,000 miles on it. 2018 has 35,000 miles on it. We had a \$4000 repair this year on the 2015. He summarized his findings on ordering and pricing.
