RESOLUTION NO. 2023-15

**A RESOLUTION TO AUTHORIZE APPLICATION FOR FINANCIAL ASSISTANCE
WITH UNITED STATES DEPARTMENT OF AGRICULTURE RURAL
DEVELOPMENT TO FINANCE PURCHASE OF POLICE AND UTILITY VEHICLES**

WHEREAS, the Town of Dayton, Indiana, (hereinafter the "Town") by and through its Town Council (hereinafter the "Council") has all powers to conduct its affairs as granted by statute, and all powers necessary or desirable in the conduct of its affairs, even though not granted by statute, under Indiana Code § 36-1-3;

WHEREAS, the Council has determined it is necessary to apply for financial assistance through the United States Department of Agriculture Rural Development (hereinafter "USDA Rural Development") to finance the purchase of a police vehicle and a utility vehicle.

WHEREAS, a public hearing on this matter was held on June 20, 2023, at 7:15 p.m. and provided the public an opportunity to opine on the purchase of the police vehicle and the utility vehicle, as well as the utilization of USDA Rural Development financial assistance;

WHEREAS, the Council has also determined a need to authorize certain Town officials to sign documents related to such purchase and financial assistance program.

NOW, THEREFORE BE IT RESOLVED by the Town Council of the Town of Dayton, Indiana:

1. The Council hereby is authorized to apply for financial assistance with the USDA Rural Development to finance the purchase of a police vehicle and a utility vehicle.

2. The Council hereby authorizes the Council President and/or the Town of Dayton, Indiana, Clerk-Treasurer the authority to sign all documents relating to the USDA Rural Development loan and/or grant.
